Sub : Change of plot for construction of Junior High School.

Dear Sir,

This is to inform you that two separate petitions, which are made by the inhabitants of Paigarah Village (under Khayrasole Block) and Chandrapur Village alongwith Resolution of Chandrapur VIII VEC (under Rajnagar Block) has been submitted before the undersigned in connection with the subject stated above. Accordingly two enquiries were made separately by this office and the followings has been revealed.

- a) It was found that the land available in Paigarah Primary School is insufficient for establishment of Jr. High School. The proposed site which is adjacent to the Paigarah Pry. school is divided into several plots and as per the enquiry report, two pits full of water are there as well as access of road is difficult. As per the enquiry report the another site (Mouza- Paigarah, J.L.No.- 163, Plot No. 854 & 855, Kh. No.- 176, 91, 237, 320, & 980) measuring around 74 decimals, which is only 500mts. away from the proposed site and sufficient as well as appropriate for establishment of Jr. High School.
- b) It was found after the enquiry, made in two different sites of Chandrapur and Kairabad and it was found the land approved by the West Bengal Board of Secondary Education is belongs to a personal property and access of road is very difficult. The VEC applied for shifting of plot from Kairabad (approved by West Bengal Board of Secondary Education) to Chandrapur J.B.School for construction of Jr. High School where land (Mouza- Chandrapur , J.L.No.- 90, Plot nos. 8185, 8585 and 8586, Area-1.74acres) is sufficient and is the property of District Primary School Council.

Under the above circumstances I am requesting you to please take necessary action for establishment of Jr. High School in the suitable areas of Paigarah and Chandrapur for the greater interest of education. Please note that the council has no objection if the Chandrapur Jr. High School is to be established in Chandrapur J.B.School instead of the proposed site for the interest of the education as well as reducing the hazards of local inhabitants.

I hope, you will be kind enough to look into the matter with your positive academic attitude so that the proposal may be settled at the earliest for greater interest of the local peoples.
