	Short listing method	A list of valid applications with marks of academic career and experience is to be prepared so that candidates may be called for verification of original testimonials and thereafter a final merit list is to be prepared.

Experience certificate must consist of:- i) Name of the organization ii) Employee's Name iii) Name of the post iv) place of posting v) Nature/type of work (part time/fulltime etc.) vi) Date of Joining in the post vii) Date of living or still continuing otherwise his/her experience will be treated as invalid. No appointment letter will be treated as experience certificate. Voluntary service will not be treated as experience.

Basic guidelines:-

- 1) **Academic marks Calculation:-** Total marks obtained in the examination will be considered (Including EVS/Additional)
- 2) **Only banker's cheque or Demand Draft will be considered**
- 3) **Experience :- will be calculated after completion of requisite qualification**
- 4) **Age:-** relaxation of age will be given for SC/ST/OBC/PH candidate as per Govt. Norms
- 5) Name of the post should be Superscripted in the enveloped
- 6) Only registered post or Courier will be accepted
- 7) All photocopies should be self attested
