After due consideration in consultations with Superintendent of Police, Birbhum, CMOH, Birbhum and Dy. CMOH I, Rampurhat Health District, Sub-Divisional Officers and authorities of Birbhum Zilla Parishad the **order issued vide Memo No. 133/C Dated 22.07.2020** has been partially modified.

In **partial modification of the earlier order**, the partial lock down measures in all Munciplities under Birbhum District shall be observed on 26.07.2020, 27.07.2020, 28.07.2020, 30.07.2020 & 31.07.2020 **on and from 12.00 Noon to 10.00 PM** of the same day.

In addition to the exceptions mentioned in the earlier order vide Memo No. mentioned above, the public dealing of banking services shall be restricted to 12:00 Noon however, the internal official activities of banking services may continue up to 3: 00 PM during partial lock down on aforesaid days.

During the lockdown on aforesaid days and time, all other restrictions and exceptions mentioned in the earlier order vide Memo No. 133/C dated 22.07.2020 shall remain same.




