NOTIFICATION

Whereas, it is observed that large number of vehicles are plying in Panagarh –Moregram Road.

Whereas, Project Director, NHAI by vide his No. 15017/1/2013/PIU(DUP)/2217 dt. 07.08.2015 prayed for regulating the vehicular movement from 11.08.2015 to 13.08.2015 for launching graders .

Now, Therefore considering all aspects and in exercise of the power under section 115 and section 116 of Motor Vehicles Act, 1988 and Section 4(1) of West Bengal Traffic Regulation Act, 1965, I Shri P. Mohan Gandhi, IAS, District Magistrate & Collector, Birbhum do hereby ordered that

(a) All light vehicles and passengers buses can ply normally without any restriction in that route 24x7 .

(b) NBSTC buses moving from Suri to Kolkata to take Ahmedpur , Futisanko, Nutanhat road .

(c) All Heavy vehicles going to Burdwan / Kolkata to take Md.Bazar-Patelnagar-Sainthia , Chowhatta- Labpur-Futisanko road.

(d)) All Heavy vehicles going to Durgapur / Asansol will take Dubrajpur-Pandaveswar route.

(e) Restriction (b),(c) & (d) are applicable between 11.08.2015 to 13.08.2015 from 6.00 am to 8.00 pm . However these vehicles are allowed to ply normally between 8.00 pm to 6.00 am on the route on the said dates .
