NOTIFICATION

Dated, Suri, the 3<sup>rd</sup> March, 2017

In cancellation of previous notification no. 281(14)/MV dated 02.03.2017 this is further notified that whereas, it has been learnt from memo. No. 249 dated 20.02.2017 of Executive Engineer, Birbhum Division, PWD that the bridge called as Mayurakshi Bridge over Mayurakshi river at Sainthia is in bad condition.

Whereas, it has been felt necessary to repair the above mentioned bridge extensively.

Now, therefore considering all aspects and in exercise of power conferred upon me under sec. 115 and sec. 116 of Motor Vehicles Act. 1988 and sec. 4(1) of West Bengal Traffic Regulation Act, 1965. I, Shri P. Mohan Gandhi, IAS, District Magistrate & Collector, Birbhum do hereby order that

- The movement of all types of vehicular traffic will remain closed from 03.03.2017 to 03.05.2017 on Mayurakshi Bridge.
- During this period Murshidabad, Sultanpur, Kotasur bound traffic from Suri sides will take diversion at Union Board more to cross Mayurakshi river through the temporary ferry ghat Road on the river.
- Similarly Suri bound traffic from Murshidabad side will take diversion at Taltala More to cross the temporary ferry ghat Road.
- Lastly traffic coming from Murshidabad and not bound from Suri will take Md. Bazar-Sainthia road which leads to NH-60.
