**NOTIFICATION**



**Whereas**, it has been learnt from Memo. No. 263/Traffic Dated 30.06.2020 of The Superintendent of Police, Birbhum & Memo No. 607 Dated 22.06.2020 of The Executive Engineer, Birbhum Division, P.W.D that there is an urgent need of road closure for 06 (six) days on & from 01.07.2020 to 06.07.2020 on Sainthia - Sultanpur road for construction of 03 (three) Cell Box Bridge (Satgharia Bridge) at 8.54 K.M. on **Sainthia - Sultanpur Road (SH-11)**.

**Whereas**, it is felt necessary to restrict all kind of traffic movement with immediate effect on Satgharia Bridge as well as Sainthia - Sultanpur Road (1.00KM to 19.00KM) to avoid any interruption of the noted construction work.

**Now**, therefore considering all aspects and in exercise of power conferred upon me under section 115 and section 116 of Motor Vehicles Act. 1988 and section 4(1) of West Bengal Traffic Regulation Act, 1965. I, Smt. Moumita Godara, IAS, District Magistrate & Collector, Birbhum do hereby order that :

- a) No vehicle should be allowed to ply on **Sainthia - Sultanpur Road** (1.00KM to 19.00KM) Upto 06.07.2020 w.e.f 01.07.2020.
- b) Movement of all types of Small vehicle (upto 4 wheeler) & Buses towards Murshidabad District be diverted from Hotinagar Morh on SH-11 (under Mayureswar P.S) to Kaleswar Morh on SH-11 (under Mayureswar P.S) via Nowapara (under Mayureswar P.S).
- c) Movement of all types of Small vehicles (upto 4 wheeler) & Buses towards Birbhum District be diverted from Kaleswar Morh on SH-11 (under Mayureswar P.S) to Kotasur Morh on SH-11 (under Mayureswar P.S) via Shibgram (under Mayureswar P.S).
- d) Movement of all kind of Goods vehicles towards Murshidabad District be diverted from Hotinagar Morh on SH-11 (under Mayureswar P.S) to Duckbaunglow Morh on SH-07 (under Burwan P.S) via Sathpalsha & Ramnagar (under Mayureswar P.S).
- e) Movement of all kind of Goods vehicles towards Birbhum District be diverted from Duckbaunglow Morh on SH-07 (under Burwan P.S) to Hotinagar Morh on SH-11 (under Mayureswar P.S) via Sathpalsha & Ramnagar (under Mayureswar P.S).
