NOTIFICATION

Dated, Suri, the 28th February, 2018

Whereas, it has been learnt from memo. no. 147/1W-66 dated 09.02.2018 of Executive Engineer, Birbhum Highway Division-I, P.W.(Roads) Directorate regarding No Parking Zone of vehicular traffic from 21.02.2018 to 31.05.2018 on the approach road of Dwarka Bridge (100 m) and 100 metre length of Mandomalinitala road is to be declared as "No Parking Zone" for a period from 21.02.2018 to 31.05.2018 as there was a need for construction of new bridge over river Dwarka on Rampurhat – Tarapith road.

Whereas, it has been felt necessary to execute this work uninterruptedly and quickly.

Now, therefore in exercise of power conferred upon me under sec 115 and 116 of Motor Vehicles Act, 1988 and 4(i) of West Bengal Traffic Regulation Act, 1955, I Shri Uma Sankar S., IAS, District Magistrate & Collector, Birbhum do hereby order that

- a) Due to construction of bridge over Dwarka bridge the both side approach road of Dwarka bridge in Tarapith P.S. has been declared as "No Parking Zone" for all vehicles from 21/02/2018 to 31/05/2018. Violation if any to be dealt as per the law in Tarapith P.S. and Executive Engineer, Birbhum Highway Division-I are requested to give wide publicity.
