

Whereas, it has been learnt from Memo. No 289/Traffic Dated 07.08.2020 of The Superintendent of Police, Birbhum & Memo No.657/W-115 Dated 07.08.2020 of The Executive Engineer, NH Division no. XII, P.W (Roads) Directorate that, hole in the deck slab of Dwarka Barrage Bridge near Deoucha at chainage 359.671 K.M of NH 60 has been observed and which needs immediate repair to avoid any accident .

Whereas, it is felt necessary to restrict all kind of traffic movement of all kind of vehicle over the damaged Dwarka Barrage Bridge on NH 60 near Deoucha at chainage 359.751 K.M to avoid any interruption of the said repair work and any mishap from 6.00 AM on 08.08.2020 to 6.00 AM on 09.08.2020.

Now, therefore considering all aspects and in exercise of power conferred upon me under section 115 and section 116 of Motor Vehicles Act. 1988 and section 4(1) of West Bengal Traffic Regulation Act, 1965. I, Smt. Moumita Godara, IAS, District Magistrate & Collector, Birbhum do hereby order that :

- a. No vehicle be allowed to ply over the Dwarka barrage Bridge up to 09.08.2020 with effect from 08.08.2020.
- b. Traffic towards Rampurhat be diverted from Md. bazar (Km 352.680 of NH-60) to Sainthia & further diverted from Taltala more Sainthia to meet NH-60 at Mollarpur (Km. 374.000 of NH-60)
- c. Traffic towards suri be diverted from Mollarpur (Km. 374.00 of NH-60) to Sainthia & further diverted from Natun bridge more Sainthia to meet NH-60 at Md. Bazar (Km 352.680 of NH-60)


