**Dated, Suri, the 1st Oct'2020**

**Whereas**, it has been learnt from the Memo. No. 338/Traffic Dated 30.09.2020 of The Superintendent of Police, Birbhum & Memo No.815/WG Dated 27.09.2020 of The Executive Engineer, Birbhum Highway Division-II, P.W (Roads) Directorate that, at a bridge at 4KM of **Khayrasole-Bara Jamtara Road** has been found in distress in the early morning of 25.09.2020, which needs immediate repair to avoid any untoward incident.

**Whereas**, it is felt necessary to restrict traffic movement of all kind of goods vehicles over the damaged Bridge at 4KM on Khayrasole-Bara Jamtara Road to avoid any interruption of the said repair work and any mishap for next 90(ninety ) days i.e upto 31.12.2020 w.e.f 01.10.2020.


**Now**, therefore considering all aspects and in exercise of power conferred upon me under section 115 and section 116 of Motor Vehicles Act. 1988 and section 4(1) of West Bengal Traffic Regulation Act, 1965. I, Smt. Moumita Godara, IAS, District Magistrate & Collector, Birbhum do hereby order that:


- a) Movement of all type of Route Buses towards Khayrasole be diveretd from Nowapara Morh (under Lokepur PS) to Khayrasole Bazar Morh (under Khayrasole PS) via Debganj & Kharikabad.
- b) Movement of all type of Route Buses towards Kankartala be diverted from Khayrasole Bazar Morh (under Khayrasole PS) to Kankartala (under Kankartala PS) via Kharikabad, Debganj & Nowapara Morh
- c) Movement of all type of Goods vehicles be restricted over the damaged Bridge until the work is completed.
