No. 01/W-115 and 06/W-115 dated 02.01.2020 of Executive Engineer N.H Division No.XII, P.W (Roads) Directorate regarding full restriction of plying of vehicular movement over the damaged Gambhira bridge at k.m. 420.421 of NH60 (near Nakpur checkpost) in the District of Birbhum & closure of road for heavy vehicles and full restriction of traffic movement from 06.01.2020 to 21.01.2020.
