- All duties, taxes, royalties, cess, GST, toll taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates prices and total Bid price submitted by the bidder.
- In case of Electrical works the agency should have personnel having **Electrical Contractors License & Supervisory license** of respective category (1, 2, 7A, 10 & 11).
