NOTICE INVITING TENDER

- 1) Tender in the letter head of the vendor will have to be submitted in sealed envelopes and is to be dropped into the locked tender box kept at the office of the Chief Medical Officer of Health, Rampurhat Health District (Room No 201, Ground Floor) **upto 2.00 p.m by 01.10.2019. Date of the opening of the Tender intimated later on.**
- 2) Rate should be offered inclusive of all taxes.
- 3) Bidder should submit both Technical Bid and Financial Bid Separately in sealed envelopes. The Name of the work and Tender Memo No should be clearly super scribed on the both sealed envelope.
- 4) For qualifying in technical bid the documents that must be submitted :- (A). Valid Trade License, (B) GSTIN Registration (C) PAN (D) Credential Certificate (Minimum Rs 1,90000.00) during last three years (E) Current P.Tax Challan (F) IT Return of last one Year (G) Current GST Return positively.
- 5) After Technical evaluation of the submitted bids through the tender committee, the participating bidders will be informed to come to the office of the undersigned on a separate day, which will be intimated later on for expressing their personal opinion on short fall documents (if any) submitted through him/her.
- 6) Sealed Sample must be submitted to office of the CMOH, Rampurhat HD upto 2.00pm by 01.10.2019.
- 7) A vendor must be qualified in technical bid for becoming eligible for opening of his/her financial bid subsequently.
- 8) The successful bidder must ensure the supply of materials within the stipulated time period as mentioned in work order. No further extension of time will be allowed. If the material is not supplied within the specified time period, the Work Order will be treated as cancelled and in that case L₂ bidder may be invited by the tender committee for supplying the order against the items after rate matching with L₁ bidder if agreed upon.
- 9) Material should be supplied strictly as per specification given. Any change in the specification will not be allowed without prior consent of the undersigned.
- 10) Rate should be quoted item wise .
- 11) Rate should be offered per unit in figure and word.
