- (a) Are properly signed;
- (b) Conform to the terms and conditions and specifications.
- (c) Quotations must be accompanied by a copy of TAN/PAN, Vat registration certificate.

D. Award of contract:

The Purchaser will award the contract to the participants whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price. Notwithstanding anything to the contrary, the Purchaser reserves the right to accept or reject any quotations and to cancel the quotation process and reject all quotations at any time prior to the award of contract.

- E. Payment shall be made after delivery and proper installation of Equipment at this office.
- F. All payments would be subject to a standard deduction of Tax and payment would be through RTGS/NEFT/Issuance of account payee cheque only.
- G. The participants must be an authorized dealer of the product manufacturing & servicing company or the company may directly participate in the quoted bid.
- H. The sealed quotations shall be received by this office up-to 25/05/2017, 14:00 hrs. at the office of the Member Secretary, DeGS & DPLO, Birbhum.
