- 2) Income Tax return should be submitted/uploaded for the last 3 (three) financial year with the Technical Bid.
- 3) Sales Tax & Professional Tax clearance certificate, GST registration certificate & Pan Card (Xerox copy) should be furnished .
- 4) The amount of earnest money is 2% of the estimated cost of construction for each work.

All duties, taxes, royalties, CESS, [including 1% CESS under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. **1% CESS under W.B.
