Sealed quotations are invited from bonafide service provider for cable net connectivity at MGNREGS Cell, Birbhum on an urgent basis.

Terms & conditions:

1. Quote Price :

- a) The contract shall be for the entire service as described above. Correction, if any, shall be made by crossing out, initialing, dating and re writing.
- b) All duties, taxes, cess and other levies payable on the raw materials and components shall be included in the total prices.
- c) Rate should be quoted including GST.
- d) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- e) During giving the supply order the no. may increased or decreased.

2. Each participant shall submit only one quotation. The participant shall submit quotation in his own letter head as per prescribed format of quotation along with his company/Dealer profile as supplier of the Equipment in a sealed envelope.

3. Evaluation of Quotation :

This office will evaluate and compare the quotations determined to be substantially responsive i.e. which

- a) are properly signed; and
- b) conform to the terms and conditions, and descriptions.
- c) Quotations/s must be accompanied with copy of TAN/PAN, GST registration certificate, P.Tax Certificate & latest P.Tax Challan (2020-21).
- d) Must attach a copy of valid dealership certificate issued in favour of concern by the service providing company.

4. The Quotations would be evaluated for entire selection process.

5. Award of Contract:

The Authority will award the contract to the participant/s whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated price.


- 5.1 Notwithstanding the above, the district authority reserves the right to accept or reject any quotation and to cancel the quotation process and reject all quotations at any time prior to the award of contract.
- 5.2 The participant whose quotation is accepted will be notified of the award of contract by the district authority prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the work order.
6. Payment shall be made after providing service at the end of each month upon submission of bills.. All payment would be subject to standard deduction of I. Tax etc. and payment would be through RTGS/NEFT/issuance of account payee cheque.
7. The participant must have credential for supply of items of similar nature in a single work order in the last five years.
8. The sealed quotations shall be received at this office on 17-12-20 upto 14.00 hrs. at the chamber of the District Nodal Officer, MGNREGA Cell, Birbhum.
9. The opening of the quotation shall be on 17-12-20 at 16.00 hrs.


