

- All credentials must be supported with work order and completion certificate/ payment certificate.
- The bidders' information sheet in excel format should be filled up properly and should be upload the same in excel format.
- Scanned Copy of affidavit as described in the SBD should be uploaded.
- Irrelevant documents must not be uploaded. (This may cause disqualification in technical bid).
- Accepted Bidder must have submit Additional Performance Security Money @ 10 % of the tender amount in the form of Bank Guarantee before issuance of the Work Order to this office, if the accepted bid value is 80% or less ( if the accepted bidder quoted rate 20 % or more less than the schedule rate) .If the Bidder fails to submit the Additional Performance Security Money within three working days from the date of issuance of Letter of Acceptance , his Earnest Money will be forfeited and necessary action for blacklisting of the contractor may be taken as per the order of Finance Department , Govt of West Bengal.**
- The Bank guarantee will be returned immediately on successful completion of the contract. If the bidder fails to complete the work successfully, the Additional Performance Security Money will be forfeited at any time during the pendency of the contract period after serving proper notice to the contractor.**

5. **Work shall be completed within the stipulated time, failing which the work order issued from this end will be treated as cancelled.**


