- All credentials must be supported with work order and completion certificate/ payment certificate.
- The bidders' information sheet in excel format should be filled up properly and should be upload the same in excel format.
- Scanned Copy of affidavit as described in the SBD should be uploaded.
- Irrelevant documents must not be uploaded. (This may cause disqualification in technical bid).
- Bidder must have accept all the norms encoded in the SBD.**
- Accepted Bidder must have submit Additional Performance Security Money @ 10 % of the tendered amount in the form of Bank Guarantee before issuance of the Work Order to this office, if the accepted bid value is 80% or less (if the accepted bidder quoted rate 20 % or more less than the schedule rate) .If the Bidder fails to submit the Additional Performance Security Money within Seven working days from the date of issuance of Letter of Acceptance , his Earnest Money will be forfeited and necessary action for blacklisting of the contractor may be taken as per the order of Finance Department , Govt of West Bengal.**
- The Bank guarantee will be returned immediately on successful completion of the contract. If the bidder fails to complete the work successfully, the Additional Performance Security Money will be forfeited at any time during the pendency of the contract period after serving proper notice to the contractor.**

The eligibility criteria are given below: -

- The applicant in the same name and style as prime contractor should have successfully completed at least one contract of same type of work at least 40 % (Forty Percent) value of the proposed contract within the last 5 years, Work Order and Payment Certificate/Completion Certificate must be uploaded.
- Income Tax return should be uploaded for the last 3 (three) financial year with the Technical Bid.
- Copy of Professional Tax clearance certificate, GSTIN registration certificate & PAN Card & last I.T clearance should be uploaded.
- All duties, taxes, royalties, cess, toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates prices and total Bid price submitted by the bidder.
- Work shall be completed within 45(forty five) days from date of issue of work order, failing which the work order issued from this end will be treated as cancelled.**
