The applicant in the same name and style as prime contractor should have successfully completed at least one contract of same type of work at least 40 % (Forty Percent) value of the proposed contract within the last 5 years, Work Order and Payment Certificate/Completion Certificate must be uploaded.
2. Income Tax return should be uploaded for the last 3 (three) financial year with the Technical Bid.
3. Copy of Professional Tax clearance certificate, GSTIN registration certificate & PAN Card & last I.T clearance should be uploaded.
4. All duties, taxes, royalties, cess, toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates prices and total Bid price submitted by the bidder.
