Attested Xerox Copy of G.S.T, I.T, P.T clearance must be submitted along with the 40% credential certificate on similar type of work from any Govt. organization, Statutory body, Autonomous body and P.S.U with Payment & Completion certificate with application, which is not refundable.

Tender form will be issued on **14/07/2021** up to **2.00 p.m.** Tender will be received on **16/07/2021** upto **1.00 pm** and will be opened at **1.30. p.m.** on the same date in presence of the intending tenderers. Tenders are to be submit in the tender box kept for this purpose in the office chamber of the undersigned. No conditional tender will be allowed in any case.


Tenderer's must quote the rate according to schedule prevailing at site and no claim for change will be entertained in future. Tenderer's should inspect the site and acquaint themselves with the difficulties and peculiarities if any.

The successful tenderer shall have execute an agreement with the Executive Officer, Suri -I Panchayat Samition Non-Judicial stamp paper worth of Rs.10/- (ten) on the cost of which to be borne by the successful tenderers. The authority reserved the right to accept or reject any or all tender without assigning any reason thereof and split the work amongst the tenderers. No interest can be claimed under any unavoidable circumstance. The work is to be started within 7(seven) days from the date of work order and shall be completed within stipulated date mentioning in the work order. In case of failure to complete the work within time the penalty may be imposed up to 10% of the estimated amount as per condition and contract of Tender and earnest money may be forfeited without any reference.

The successful tenderer shall be bound to supply up to 20% of the excess materials as per tender schedule at the same rate of his tender as per order of Executive Officer, Suri -I Panchayat Samiti. The successful tenderer shall be responsible for guarding the materials supplied by him until those are fully consumed. The payment will be made as per recorded M.B. after observing financial formalities as per Govt. rules. The materials (Cement, Rod, etc.) require for construction work shall not be issued from the Department.

Payment will be made as per PWD & Sanitary plumbing schedule after completion of work (of any item not included in the tender schedule).
